GAR LIMITED ANNOUNCES CLOSING OF FIRST TRANCHE OF OVERSUBSCRIBED PRIVATE PLACEMENT AND ANNOUNCES PROPOSED SECOND TRANCHE

GAR Limited ("**GAR**" or the "**Company**") (**CSE: GL**) is pleased to announce that it has now closed its previously announced (see press releases dated November 20, 2017) non-brokered private placement offering (the "**Offering**"). In connection with the Offering, the Company issued 23,835,737 common shares in the capital of the Company (a "**Share**") at a price of \$0.35 per Share for gross proceeds of \$8,342,507.95.

In addition, the Shares will be subject to a 9-month restricted hold period and will be available for resale in accordance with the following schedule: (i) 25% no additional hold period; (ii) 25% subject to voluntary hold period of 3 months expiring on February 28, 2018 Date, (iii) 25% subject to voluntary hold period of 6 months expiring on May 30, 2018, and (iv) 25% subject to voluntary hold period of 9 months expiring on August 30, 2018.

The net proceeds from the Offering are expected to be used to fund the Company's acquisition of Netcoins Inc. (see press release dated November 20, 2017) and for general corporate purposes.

In addition, due to overwhelming demand, the Company is also pleased to announce that it intends to complete a second tranche closing (the "Second Tranche").

Closing of the Second Tranche is subject to a number of conditions, including receipt of all necessary corporate and regulatory approvals, including the CSE.

The Second Tranche is not subject to a minimum aggregate amount of subscriptions. A finder's fee may be paid to eligible arms length finders in accordance with CSE policies.
